The app is designed to resemble CPDLC a quick concise textual method for flight crews to communicate with FBO's. Our Facebook group Private Jet Pilots (PJP) has over 4600 active members and our census is better than 80/20 aircraft equipped with WiFi. Flight crews come identified by tail number and aircraft type simplifying requests, keeping communications between your team members visible, accountable and accessible . The inbound aircraft or planning crew can request services, order specific fuel quantity through the app, make requests and use the app as a messaging app between the aircraft and FBO.
